Description

Guide Price £220,000 - £230,000.

This detached bungalow is available with no onward chain and enjoys a cul de sac location just a short walk (approx 0.6 miles) from Lakenheath village high street, shops and amenities.

The property comprises a welcoming, central entrance hall providing access into two double bedrooms, lounge, fully fitted kitchen and a shower room. There is also a conservatory to the rear of the bungalow, overlooking a well maintained wrap-around garden.

The kitchen offers a range of wall and base level units, stainless steel sink and drainer, useful pantry storage cupboard plus ample space for appliances. The kitchen is also home to an oil boiler, which serves the oil fired central heating system, and an airing cupboard housing the hot water cylinder.

The shower room comprises W.C, wash hand basin and electric shower cubicle.

Outside, the bungalow includes a detached garage, with window to rear, and driveway off street parking space in front, in addition to a wrap around garden to the rear and sides of the property which is predominantly laid to lawn and includes the oil tank and a useful storage shed.

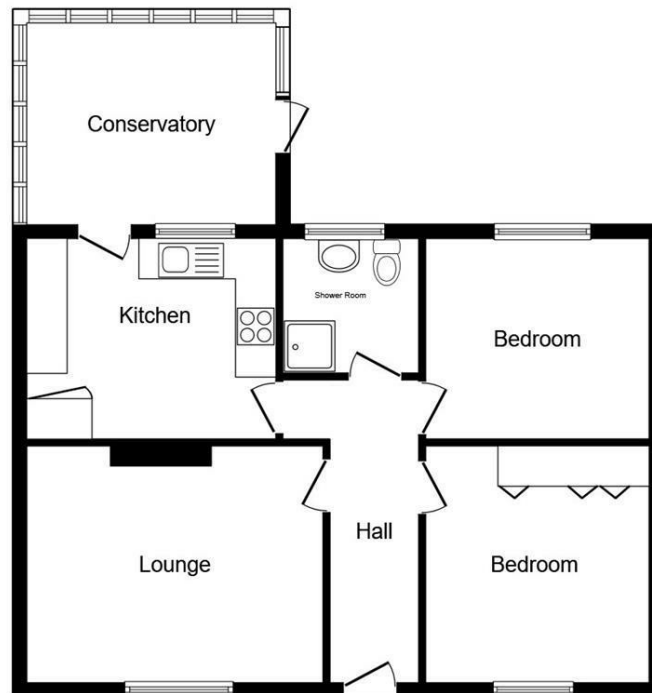

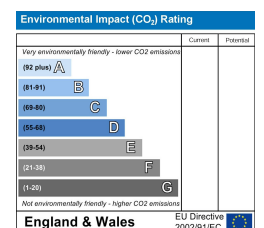
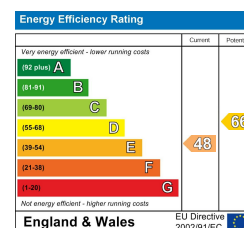
